



Waiver and General Release of Liability Relating to Coronavirus/COVID-19

Land Ops Nav-Comm Operations (event)

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

Land Ops ARC including each of their affiliates, subsidiaries, members, employees, officers, aides (the “Released Parties”), cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while participating in any Land Ops ARC event. It is not possible to prevent against the presence of the disease. Therefore, if you choose to participate in this event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19.

I hereby choose to accept the risk of contracting COVID-19 for myself, and for my family members or others who I may expose, in order to participate in this event. These events are of such value to me that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to participate in this event.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against the Released Parties in connection with exposure, infection, and/or spread of COVID-19 related to my participation in the event. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence, and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

OTHER TERMS: I fully understand and agree that (a) this Release is intended to be as broad and inclusive as permitted by the laws of the State of California or the state in which the event takes place; (b) if any portion of this Agreement is for any reason held invalid or legally unenforceable, then the balance shall, notwithstanding, continue in full force and legal effect; and (c) I have had the opportunity to ask any questions about this Agreement and I fully understand its terms and meaning. I also agree to comply with any Plan, Rules or other Conditions that Land Ops ARC may impose on attendees of the event.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS WAIVER AND GENERAL RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE:

Land Ops Nav-Comm Operations - COVID19 Plan

- All participants, including staff, friends or family attending with event participants, and volunteers must answer the questions below before arrival via phone or email.
 - In the last 14 days have you had a fever greater than 101.4, shortness of breath, body aches or coughing (not attributable to allergies) or been diagnosed with COVID 19 (presumptive or positive test)?
 - **If so, do not attend event**
- In the last 14 days have you had close contact with someone who may have COVID-19) This includes anyone with a positive COVID-19 test or who has COVID-19 symptoms (fever greater than 101.4, shortness of breath, body aches or coughing, (not attributable to allergies))?
 - **If so, do not attend event**
- In the last 14 days have you assisted in the care of an individual (outside your household) who is not well
 - If so and you were wearing proper PPE (Including N95 mask), please take extra caution by maintaining strict social distance and wearing face covering
 - **If so and you were NOT wearing PPE do not attend event.**
- In the last 14 days have you returned from another country or high-risk area?
 - **If so, do not attend event**
- All staff, volunteers, and participants should stay home if sick or any of the answers above are affirmative.
- Use of face coverings/masks by staff, volunteers, and participants is required anytime they are outside of their individual camp.
- Initiate, practice, and remind others of social distancing.
 - Campers will be encouraged to keep 60 feet between camps
 - When outside of own camp, avoid physical contact, handshaking, hugging etc.
 - Children should remain in care of their own household members.
 - Conduct briefings and conversations outdoors and at least 6 feet apart.
- Due to the COVID19 restrictions this year's Ops will be different from past years.
 - No organized group potluck will take place.
 - Individuals are always encouraged to keep at least 6 feet between others.
 - Wear face coverings if you need to enter another camp or group gathering.
- Net Control staff will practice social distancing and wear face coverings at all times when in the company of others.
- Drivers meetings will be conducted outdoors, and everyone must stay at least 6 feet apart and wear face coverings.
- When searching for Caches, please be aware of your distance between other Operators and wear your mask. It is suggested to use hand sanitizer after touching objects that others may have previously touched. In other words, you will be expected to exhibit safe behavior based on CDC Guidelines and other common-sense actions as described herein.
