01. **Absolutely NO DRINKING and DRIVING**
If you drink and drive you will be banned from the event and your membership terminated.
02. **NO DRUNKS, NO LOUD MOUTHS, NO LOUD MUSIC, NO FOUL LANGUAGE or ANY OTHER KIND OF DISTURBING THE PEACE.**
03. **Keep a Peaceful Camp - quiet time each night is 10:00 PM**
Please be considerate of others by lowering your voices after 10:00 PM. RV generators are acceptable as long as they are not excessively loud. Tent campers should avoid camping close to trailers with generators if you are sensitive to the generator noise. Camp a good distance away if generator noise bothers you. Note: net control often times must keep radios on late at night to monitor incoming and outgoing members. Please be aware of this before setting up your camp right next door.
04. **Street Legal**
All vehicles, including ATVs, must be properly licensed, tagged and in compliance with all laws. This is your responsibility.
05. **Pet Policy**
Friendly dogs are welcome. Unfriendly, intimidating dogs with issues will be banned. If your dog has problems with anyone in our group, the owner of the dog may be asked to leave.
06. **Tread Lightly and Trash In/Trash Out**
Stay on all designated trails and obey all posted signs. Take trash with you. Leave nothing behind.
07. **Weapons Policy**
Land Ops is not a gun or shooting club, however we realize that many people carry firearm protection where we go. All members must obey state and federal laws with respect to possession, transportation and use of firearms. Please refrain from shooting in or around the base camp area and where other members are operating.
08. **Cooperate with Organizers and Overwatch Operators**
We're all out to enjoy the unique Land Ops games. Organizers have the extra burden of enforcing the rules, conducting activities, and assisting you. Your good attitude and cooperation are much appreciated.
09. **Mindset, Attitude and Conduct**
Land Ops are moderately challenging exercises that are best solved by teamwork. However, things do not always go as planned, people have different personalities, and chaos always seems to be around the next corner. To be a successful operator in our group you must learn to adapt, work as a team even when you may not agree with others. This should be your mindset. Keep a positive attitude and always conduct yourself in a professional manner.

RELEASE OF ALL LIABILITY - I understand that driving off road, recovery vehicles, camping in remote areas, geocaching, search and rescue drills, wild animals in and around the event(s), hiking, rappelling and all other related activities introduced and associated with the Land Ops event(s) can be EXTREMELY DANGEROUS and EVEN DEADLY. I attend the Land Ops event(s) knowing full well that my safety, health and life may be at risk. I am aware of the dangers associated with desert, mountain, water and canyon terrain including, but not limited to; open mine shafts, cliffs, flash floods, vehicle roll over hazards, off camber driving, colliding with other vehicles, excessive heat conditions, freezing cold conditions, lack of facilities and nearby medical services, long delays in getting help, poisonous snakes and other insects, poisonous plants and animals, other people carelessness, people with firearms, vehicle breakdowns, and human error. I acknowledge these dangers and desire to participate in the Land Ops event(s) at my own risk. I hereby state that I am solely responsible for my own safety, insurance and well being and hold no one associated with Land Ops accountable or liable for any accident, personal harm, physical trauma, personal injury, illness, allergic reactions, loss of life, vehicle loss or damage, property loss or damage, financial loss, emotion trauma, or any other kind of suffering or loss.

I FULLY RELEASE Land Ops, it's owners, members, associates, sponsors, relatives, companies and organizers from any liability or responsibilities for my own well being and those under my care. I furthermore agree not to sue any of the parties mentioned above for any reason whatsoever. I take full responsibility for my own safety and the safety of others around me as well as my property, vehicle and equipment. I understand I must obey all federal and state laws and carry my own vehicle insurance where required.
